- CAL (A-00) Because of the time required this cannot be taken with any other selection.
CRL Level: L-00 + two (2) Electives. Choose the Mandatory and two (2) Electives.
CPL Level: CRL + twelve (12) Electives. Choose 12 electives. Do not choose any Electives passed previously for CRL.
CML Level: CPL + nine (9) Electives. You may take up to (12) electives. Do not choose any Electives passed previously for CRL or CPL.
Re-Take CRL Level: If you did not pass the Mandatory, you must choose the Mandatory. You may also take one (1) or two (2) Electives if you did not pass one (1) or two (2) Electives, but you may not take extras.
If you passed only the Mandatory, choose any twelve (12) Electives
Re-Take CPL or CML Level: choose any twelve (12) Electives.
CPS Level (S-00): Because of the time required this cannot be taken with any other selection.
